

Impact reporting has grown exponentially in value over the last decade, with national research assessment frameworks in the UK, Australia and Hong Kong already requiring systematic impact planning and reporting from research organisations as part of these frameworks which are worth more than a billion pounds in research grants and Quality-related Research funding.

Impact data has become key for making the business case for investment in research, and whilst the funding landscape is subject to changes, the requirement to demonstrate the wider impact of research continues to grow.

Used at approximately 50 universities worldwide, including Russell Group members; VV-Impact Tracker is powered by VV-Impact Metrics, a framework that prompts and guides academics and organisations in identifying, capturing, managing and presenting their research impact. Additionally, it comprises of VV-Impact Reviewer* which enables universities to automate and manage all of their processes for conducting internal impact reviews.

Overview

The morning provides attendees with a clear understanding of what Impact is, why it is important and the key principles behind a 4* Impact case study. Attendees break out into small groups to assess a mixture of REF 2014 Impact case studies. After lunch, attendees have the opportunity to discuss their research project during their one hour 1-2-1 session with the trainer. Trainer will develop with the attendee their Impact Maps, identifying who their stakeholders are, what activities have taken place and what outcomes have been achieved. Together they will identify the key headlines for their Impact Case Study by the end of the session.

For E02a, research office members will also do role plays and other exercises to further their understanding, individual capacity and confidence to work with academics and support the impact of their research.

VV-Impact Tracker based training

Getting started with VV-Impact Tracker

(for Academics) [Course code: E01]

Overview

This half day session provides an initial 45mins overview of what Impact is, why it is important and the key principals behind a 4* Impact case study. It then provides a walk-through of VV-Impact Tracker and then passes over to the Attendees to log in to the software and start creating their research projects in the VV-Impact Tracker. There is support from the trainer on how to use the software and discussions about what Impact looks like in their research taking place.

What is Impact? (VV-Impact Tracker Overview & Demo)

(for Research & Enterprise Committees)

Overview

This overview and demonstration is an opportunity for your academics to trial VV-Impact Tracker live and provide feedback on the software to you. The session will start with a brief overview of the software and then it is the attendees turn to log in and start creating their projects in VV-Impact Tracker. There is support from the trainer on how to use the software and discussions about what Impact looks like in their research projects.

VV-Impact Tracker Refresher

(for UoA Leads & Academics)

Overview

These 2 hour sessions provide an initial overview of what Impact is, why it is important and the key principals behind a 4* Impact case study. It then provides a walk through of VV-Impact Tracker and then passes over to the attendees to log in to the software and start creating their research projects in the VV-Impact Tracker. There is support from the trainer on how to use the software and discussions about what impact looks like in their research taking place. The focus is to create at least one storyboard per attendee.

Developing Impact themes for your Impact Case Study (for Academics)

Overview

Attendees discuss their research project during their one hour 1-2-1 session in the morning. Trainer will develop with the Attendee their Impact Maps. These identify who their Stakeholders are, what Activities have taken place and identify what Outcomes have been achieved. Working with the trainer, Attendee creates their Storyboards on VV-Impact Tracker, based on key Impact themes, identifying key headlines for their Impact case study. After lunch, Attendees come together to use their individual Impact Maps to update and draft their Impact case study narratives in VV-Impact Tracker.

Mock Interviews

(for Academics & Research Office)

Overview

Within a Faculty/Department, academics likely to have a potential Impact case study are invited to present (including VV-Impact Tracker) on their potential Impactcase study to a small review panel. This is followed by Q&A to try and further determine robustness and what else could be done to maximise 'reach and significance'. Attendees identify key actions from the panel to improve their Impact case studies. Panel also notes how well developed the project is, and what key actions need to be taken to further develop it (ahead of any internal Mock REF Panel Review).

Mock REF Panel Reviews

(for UoA Leads) [Course code: IO5]

Overview

Designed to review internal university-wide Impact case studies in each of their Main Panels. All potential Impact case studies must be completed in VV-Impact Tracker. Research Office distributes each project to Panel members ahead of Mock REF Panel Reviews. The trainer delivers an overview of what Impact is and what makes a 4* Impact case study for Attendees, ensuring a consistent understanding. Research Office prepares the scoringmatrix and all potential Impact case studies are provided to Panel members, where UoA/Main Panel/Impact Leads, provide summary commentary, for discussion, with notes distributed to the impact case study authors.



eLearning modules on research impact

COURSE 1:

What is Research Impact?

This is an introductory course to research impact. It will cover the key concepts in research impact as well as impact reporting: What is impact and why is it important? How has the field of research impact developed over the years? What national assessment frameworks include impact and what's impact's role in funding applications? The course answers these questions and more and will give you a good, basic starting understanding of what research impact is.

COURSE 2:

Identifying Impact

This is the second course in our 4-course pathway. It will go into more depth on how to identify research impact. What are the different components you should be looking at?

We will cover stakeholders, outcomes, impact activities and indicators. Knowledge of what these concepts consist of and how they plan them is a crucial first step in creating your impact narrative.
